

2018 CNH Industrial / Case IH Sprayer Visa Gift Card Sweepstakes Official Rules

Entrants must register online by visiting the website <http://caseih.com/sprayer-sweepstakes> completing the registration form and then verifying the email entered. Limit one entry per person ("Entrant"); duplicate entries by an Entrant will be voided and may disqualify the Entrant(s) from winning a Prize in this Promotion. Any form of entry other than those described herein is void, and any incomplete or otherwise non-conforming entries including mechanically produced copies, will not be accepted or eligible to win and will be disqualified.
