#### Explanatory Statement Pursuant to Section 102 of the Companies Act, 2013

Presently, the Registered Office of the Company is situated in Mumbai in the State of Maharashtra, whereas almost all the operational and management activities of the Company are being carried out from its Corporate Office situated at Gurugram (Haryana) Keeping in view the administrative convenience, cost effectiveness, growth potential and the opportunities existing, it is proposed to shift the registered office of the Company to New Delhi in the State of Delhi.

Accordingly, your Board of Directors of the Company in their meeting held on June 20<sup>th</sup> 2018 had approved and proposed the shifting of the registered office of the Company from Mumbai in the State of Maharashtra to New Delhi in the State of Delhi.

In accordance with the provisions of Section 13 of the Companies Act, 2013 and other applicable provisions of the Companies Act, 2013 read with Rule 30 of the Companies (Incorporation) Rules, 2014, pursuant to the shifting of the Registered Office from one state to another, 'Clause - II' of the Memorandum of Association of the Company relating to the Situation Clause need to be altered, which requires the approval of Members in the Extraordinary General Meeting by way of Special Resolution and subject to consent of the creditors/ debenture-holders and other persons concerned with the Company and further to the confirmation of the Hon'ble Regional Director, Northern Region, New Delhi and other statutory approvals. Therefore, it has become necessary to seek your consent by way of special resolution to give effect to such change.
